The 1880 Census listed as " Jay "; 1900 Census listed as " Jay G " and 1910 Census listed as " Jay " 1920 Census listed as " Patrick " 1930 Census listed as "Patrick J."

Possible First Marriage: 1910 Census - Marion Co., in Salem City at 1191 Oak Street as a broader, there is a Jay Maxfield, age 36 (born 1873/74) born in OR. Occup. was Blacksmith in a shop. Lists Father and Mother born in IA. Also listed is a Jeanie P. Maxfield as Jay's wife, married 3 years (1906/07). Her age was 45 (born 1865) in NJ. Occup. Cook at a Hotel. Her Father was born in England and Mother MA. This the only Jay Maxfield in the 1910 Census Index in OR or CA. Also there is no P.J., Patrick J., Patrick Jay Maxfield in the 1910 Census Index for OR or CA.

In a speech read by Marge Stanton Cohe, Mrs. Estes also was recognized for her love of children and animals.

She obtained a master's degree in education from Chico State University and has been Chico Unified School District for the past nine years as a Miller Unruh reading specialist and a Title I resource teacher. In another educational realm, she has attained the title of professor in the area of martial arts.

With spirit of service to the community and to one another, Beta Sigma Phi members awarded one woman from each of the five chapters the 'Woman of the Year' award.

Besides his wife Lukie, he leaves a son Kimo Estes of Mountain View, CA, a daughter Arlene Estes of Stockton, CA; two brothers, the Rev Ivan Estes of Nevada City and Burl Estes of Winston; a sister Patricia Estes Allen of Sacramento; four grandchildren, one great-grandchild and many nieces and nephews.

Bud was known as Prof Estes and was nationally known in martial arts circles, and held the highest ranking - 10th degree black belt- in jujitsu, from which modern judo evolved.

Bud died in Corning, NY, where he was teaching a martial arts seminar. Cause of death was an apparent heart attack.

From the "Kiai Echo" The American Judo & Jujitsu Federation Vol 7, No. 1 Summer - 1981 Memorial Issue Professor Bud Estes Judan:

A letter to all JuJitsuka everywhere from Lukie (Professor Lucille Estes) she states that it was her great privilege to have shared 36 years (1945 - 1981) of his (Bud)- (really 41 years, because he was my ( Lukie's) Sensei for 5 years before we were married.

" Leslie J. Maxfield was born May 30, 1922 to Patrick J. and Daisy Maxfield in Alsea, Oregon, being the oldest son of nine children.

He met Lavonne Leslie in Eureka, California while working at a lumber mill. During his early twenties while courting LaVonne he answered the call of his country to serve in the armed service in the Army Signal Corp, where he achieved the rank of Sargent.

Soon after his enlistment, he married Lavonne Leslie June 27, 1943 in Chicago, Illinois.

As their lives together began to unfold they were given the blessing of raising four children, one son and three daughters.

After being discharged from the Service he gained employment with the Southern Pacific Railroad, at their Sacramento shop as an electrician. It was here he joined the International Brotherhood Electrical Workers Union Local 800. He worked for Southern Pacific for twenty years 1945 to 1965. It was during his employment at the railroad in 1955 that I first met Max both of us being electricians and finding our paths crossing in our labors. As I later left the railroad and left the state, little did either of us give thought that our paths would cross again.

Max later was employed by the State of California for a year and a half and the County of Sacramento for fourteen years.

We did not remember each other as fellow workers of years past. We were invited into their home and they permitted us to visit often and explained the Restoration of the Gospel of Jesus Christ in Its Fullness.

Max and Lavonne joined the Church December 18, 1982. Where they made new friends who love and care about them.

Max was my home teaching companion, I so very much enjoyed our labors as we went about teaching the Saints and know that we shall meet again and we will again have the opportunity to serve together.

I will remember him as a proud man yet one who later in his life recognized the Master's voice when given the opportunity to hear it through his servant's, humbled himself and accepted the change that must come to us all making us worthy to return to Him the Creator and Father of us all.

That dream was fulfilled when they moved to CA and settled in Eureka in 1941. Both Fred and LaVonne worked in one of the local lumber mills. In 1942 her marriage to Fred broke up.

While working at the mill LaVonne met Leslie Maxfield and when Leslie went to Chicago, IL, for the Army, in

1942, LaVonne and Charlene followed him. LaVonne and Leslie Maxfield were married in 1943 in Chicago, IL. While in Chicago LaVonne was a pitcher for the women's Chicago Clubs softball team. In 1944, after Leslie's discharge from the Army, the family moved to Sacramento, CA.

One of her proudest accomplishments was to earn her high school diploma in 1958.

She was a very active person and realized many of her dreams. She parachuted out of an airplane, went flying in a hang glider, and went up in a hot air balloon. She traveled around Europe, and at one point lived in HI. She also owned a motor home and used to explore the States.

She loved playing music and in her later years, belonged to a band. The band would perform in "Old Folks Homes" delighting those individuals that could no longer get out. She thought of herself as a "Recycled Teenager".

She loved collecting things and there was nothing she didn't collect. She also loved animals. Over her lifetime, some of her "pets" included dogs, cats, mice, rats, birds, squirrels, monkeys, piranhas, and a Venus fly trap.
